Re: California State Non-Profit Security Grant Program announcement

The Governor's Office of Emergency Services (CalOES) has released information about the 2022-2023 California State Non-Profit Security Grant (CSNPSG) program. This grant, like its federal counterpart, offers funding for "physical security enhancements and other security-related activities to nonprofit organizations that are at high risk for violent attacks and hate crimes due to ideology, beliefs, or mission." Houses of worship and religious facilities fall into this category, even if they have not experienced a direct threat or act of violence to a specific facility.

Historically, language inserted by CalOES into the standard assurances for both the state and federal grants presented an obstacle to Catholic organizations seeking these funds. Through the efforts of the Sacramento Diocese, CalOES modified the wording in these assurances earlier this year and two Sacramento parishes were able to receive approximately \$200,000 each for security upgrades in the last CalOES grant cycle.

This grant is a competitive process offering up \$200,000 per location for a total of \$600,000 for separate locations operated by the same applicant.

The attached CalOES grant management memorandum describes five grant application workshops scheduled between September 8 and September 22. Two workshops will be webinars and the remaining three will be "live" (one in San Diego, one in Rancho Cordova, and one in Dublin). The memorandum also includes a link to the CSNSPG request for proposal and application information.
