Re: Grant application information - Time sensitive

Applications for the California State Non-Profit Security Grant ("CalOES grant") must be submitted by October 28. This is one of two annual grant opportunities (the other being a federal grant that has already closed for this year) available to non-profit organizations that are at "high risk for violent attacks and hate crimes due to ideology, beliefs, or mission". CalOES provided five grant application workshops for organizations interested in applying for this grant.

While the CalOES grant application workshops have ended, there is still an opportunity to learn about the federal and state grant application processes from persons involved in writing successful grant applications.

Carrie Johnson, the Executive Director of the Rancho Cordova Food Locker which is located at St. John Vianney Parish, Rancho Cordova applied for the federal homeland security grant earlier this year. the parish was notified just last week that they were successful in their application and will receive \$150,000 for security improvements.

David Byrnes and Lynda Struebing are parishioners at St. Peter/All Hallows,' Sacramento, and were two of the primary authors of the parish's successful application for last years' CalOES grant. St. Peter/All Hallows' was notified this spring that the parish will receive \$200,000 for security upgrades.

Carrie, David, and Lynda have generously offered their time to talk about their grant writing experiences in a ZOOM meeting hosted by Carrie Johnson on Thursday, September 29 at 3:00PM. This will be an informal presentation with time for questions and answers about the challenges encountered in applying for these grants.

If you are interested in learning more about what work was involved in either the CalOES or federal non-profit security grant applications, I encourage you to participate in this meeting.
