Re: Notice of Funding Opportunity – Federal non-profit security grant program

---

Cal-OES has released the FY2023 notice of funding opportunity for the DHS/FEMA non-profit security grant program. This grant is the FEDERAL counterpart of the CalOES state grant program that many Sacramento Diocese parishes and schools succeeded in obtaining last year.

This grant offers \$150,000 per site to non-profit organizations for target hardening efforts to, “... prevent, protect against, prepare for, and respond to terrorist or other extremist attacks.” Entities with multiple locations (for example, a parish with a church, school, and parish life center) each with different addresses or located on separate lots can make up to three applications for a maximum award of \$450,000.

This is a competitive, nationwide grant process. This year, the federal government allotted \$305 million dollars for the grant, an increase of \$55 million from last year.

Although this is a federal grant, CalOES acts as DHS/FEMA’s “state administrative agency” and plays a large role in managing the grant. Please see the CalOES Grant Management Memorandum for information about application documents and grant application webinars. I strongly encourage interested persons to participate in one of the webinar opportunities.

CalOES has established a **5 PM** deadline on **APRIL 14, 2023** for grant submissions. This is the deadline that all California applicants **MUST** adhere to since CalOES prescreens applications before they are sent to DHS/FEMA.

This link provides access to detailed information about the grant application and scoring process (CalOES can impose additional requirements that will not appear in this material). This link lists a submission deadline of May 18, 2023, for applications. DO NOT follow this deadline - this is the date that CalOES must submit California applications to DHS/FEMA. California non-profits applying for the grant must have their applications submitted to CalOES by 5 PM on April 14, 2023.

The California Governor's Office of Emergency Services (Cal OES), Grants Management, is pleased to announce the FY 2023 NSGP Application Webinars to explain the NSGP requirements, and assist nonprofit organizations with the application process.

The NSGP is focused on target hardening activities. Funding can be used for the acquisition and installation of security equipment on real property. Nonprofit organizations that are eligible to submit applications for the FY 2023 NSGP are those organizations that are described under Section 501(c)(3) of the Internal Revenue Code of 1986 and exempt from tax under Section 501(a) of such code.
