Re: CalOES Grant Management Memo

CalOES distributed the attached grant management memo (GMM 2024-09) last Friday afternoon. Unfortunately it arrived after the submission deadline for the June 17 Diocese weekly bulletin.

The memo is directed to organizations that have received the **federal non-profit security grant in fiscal years 2019, 2020, 2021, 2022, and 2023**. CalOES scheduled four webinars to assist recipients with documentation requirements for the grant's bi-annual strategy implementation report which is required by FEMA. The two remaining webinars are scheduled for June 26.

I was told parishes and /or schools that received funds from this grant in the period described above should participate in the webinars or contact their assigned CalOES grant representative to ensure their grant documentation is complete.

Again, this is only directed to parishes and/or schools that have received funding from the federal non-profit security grant program between 2019 and 2023.

In preparation for submission of the June 2024 BSIR, Cal OES will be hosting webinars to provide technical assistance for completing the BSIR. HSGP and NSGP Subrecipients will need to report on FY 2019, FY 2020, FY 2021, FY 2022, and FY 2023 funding. EMPG Subrecipients will need to report on FY 2022 and FY 2023.

The June 2024 BSIR is due to Cal OES by COB Monday, July 8, 2024
